**DOWN PAYMENT BOND GA-1193**

This undertaking will come into force on the date of receipt by the seller on his account n° FR76 1080 7004 1375 0215 7632 941 held with Banque Populaire Bourgogne Franche-Comté of the aforesaid down payment and will automatically be reduced up to 100% of the value of the shipments made which will be evidenced by the collection in our books by the seller of the sums due according to the contractual terms as the shipments are made.

In any case, it will cease to be valid on 31 December 2016.

Consequently, any claim or call for payment is to be received at our Département International of Banque Populaire Bourgogne Franche-Comté, 1, place de la 1<sup>ère</sup> Armée Française, 25087 Besançon Cedex 9, France, through a bank which will have to certify signatures and attest that said signatures are validly committing the beneficiary, at the latest on 31 December 2016. Thereafter, the present undertaking will automatically become null and void and will no more be enforceable whether it is returned to us or not.

Any payment made in accordance with this down payment bond will proportionally decrease the amount of our commitment.

This down payment bond may only be assigned or transferred with our written consent.


