(9) Guarantee of Quality: The seller shall guarantee that the goods correspond in all respects with the quality, specifications and performance as stipulated in this contract.

质量保证：卖方保证交运货物数量、分析证明、质量和参数符合合同要求，并按照合同装运包装。

(10) Letter of Bank Guarantee: in 1 original issued by French Bank before Buyer T/T the payment; The costs of the Bank Garantie will be covered by the Seller. If buyer doesn't receive the goods before the agreed date, Bank will repay the total amount to Buyer. The Bank Garantie Original shall be handed over to the buyer before **July 10th, 2017.**

银行保函：在买方电汇货款前，由法国银行对本合同开具银行保函原件一份。开具银行保函所产生的费用由卖方承担。如果买方在规定提货日期前未能从卖方处提货，银行将赔付买方全数等值货款。银行保函原件需在**2017年7月10日**前提供给买方。

(11) Transfer of Possession and Risks: The possession of the Products shall be transferred to the Buyer as soon as the total amount of this Contract has been paid to the Seller. The transfer of risks in the Products shall occur as they are handed over to the transporter by the Seller.

所有权与风险转移：自买方支付完毕货物全部总价后，货物所有权转由买方所有；自卖方将货物交付承运人后，货物风险转由买方承担。

(12) Force Majeure: In case of Force Majeure, the Seller shall not be held responsible for delay in delivery or non-delivery of the goods but shall notify immediately the Buyer by fax and deliver to the Buyer by registered mail a certificate issued by government authorities or chamber of commerce as evidence thereof. If the shipment is delayed over one month as the consequence of the said Force Majeure, the Buyer shall have the right to cancel this Contract. Seller inability in obtaining export license shall not be considered as Force Majeure.

不可抗力：由于人力不可抗拒事故，使卖方不能在合同规定限期内交货或者不能交货，卖方不负责任。但卖方必须立即以传真通知买方，并以挂号函向买方提出有关政府或者商会所出具的证明，以证明事故的存在。由于人力不可抗拒事故致使交货延期一个月以上时，买方有权撤销合同，卖方不能取得出口许可证不得作为不可抗力。



(13) Arbitration: All disputes in connection with this Contract or the execution thereof shall be settled through friendly negotiation. In case no settlement can be reached through negotiations, the case should then be submitted for arbitration to China International Economic and Trade Arbitration Commission (CIETAC), Shanghai Commission, in accordance with International laws and international practices when applying its Rules of Procedure. The arbitration shall take place in Shanghai. The award rendered by the said Commission shall be final and binding upon both parties, the arbitration fee shall be borne by the losing party.

仲裁：在履行协议的过程中，如产生争议，双方应友好协商解决。若通过友好协商未能达成协议，则提交中国国际贸易仲裁委员会上海分会，根据该会仲裁程序暂行规定进行仲裁。该委员会决定是终局的，对双方均有约束力。仲裁费用，除另有规定外，由败诉方负担。
