

**SUPPLY AGREEMENT**

between

and

**Maison PARENT-GROS**

**LBSC GmbH, Zug branch**, a branch of the Swiss company LBSC GmbH, having its registered address at Baarerstrasse 71, 6300 Zug, Switzerland, registered in the Commercial Register of Zug under number CHE-338.424.166, VAT number CHE-338.424.166 MWST, hereinafter referred to as the “Buyer”, represented by the Managing Director of LBSC GmbH Yann Tarabori, acting on basis of the Articles of Association,

and

**Maison PARENT-GROS**, a company organized and existing under the laws of France, having its registered address at 1 Place de l'Europe 21630 Pommard France, represented by its duly authorized representative(s) Caroline PARENT, acting on the basis of the Statute (hereafter referred to as the “Seller”), on the other part,

hereinafter referred to as “the Parties”.

## **1. SUBJECT OF THE AGREEMENT**

1.1 The Seller has agreed to sell and the Buyer has agreed to purchase some or all alcoholic or non-alcoholic drinks currently existing, or to be developed, produced and/or distributed by the Seller (hereinafter referred to as the “Goods”) in accordance with terms and conditions specified hereunder in this Supply Agreement.

## **2. DELIVERY DATE**

Unless otherwise agreed in writing by the Parties, the delivery of the Goods shall be made on EXW Beaune basis as defined by the INCOTERMS 2020.

## **3. PAYMENT**

3.1 The payment to be made by prepayment. The invoice issued by the Seller shall not be dated earlier than the date of dispatch of the Goods specified by the invoice.

## **4. TERM**

This Supply Agreement shall be valid for a period of 5 (five) years as from its execution date (hereinafter referred to as “Initial term”).

The parties shall always have the right to terminate this Agreement by mutual consent


